

Cultural Disintegration and Loss Homelessness

Homelessness that totally dislocates or alienates Indigenous individuals and communities from the relationship web of Indigenous society known as "All My Relations."



Overcrowding Homelessness The number of people per dwelling in urban and rural Indigenous households that exceeds the national Canadian household national Canadian household average, thus contributing to and creating unsafe, unhealthy and overcrowded living spaces, in turn causing homelessness.

Relocation and Mobility Homelessness

Mobile Indigenous homeless people travelling over geographic distances between urban and rural spaces for access to work, health, education, recreation, legal and childcare services, to attend spiritual events and ceremonies, have access to affordable housing, and to see family, friends and community members.

Going Home Homelessness An Indigenous Individual or family who has grown up or lived outside their home community for a period of time, and on returning "home," are often seen as outsides, making them unable to secure a physical structure in which to be, due to feterar, approximati, kernitorial or municipal bureauvratic barriers, uncooperative band or community councils, hostile community and kin members.

Nowhere to Go A complete lack of access to stable shelter, housing, accommodation, shelter services or relationships; literally having nowhere to go
