What is the right to adequate housing?

"The right to live somewhere in security, peace, and dignity."

Adequate housing is:

- Affordable
- Safe
- Secure
- Accessible
- Habitable
- Culturally appropriate
- Connected to services & amenities

Right to housing is at the centre of other rights

- Fundamental rights: human dignity, selfdetermination
- Civil rights & freedoms
- Political rights
- Equality rights

Recognition of the R2H

International UN Covenants Canada has signed

- Covenant on Economic, Social, and Cultural Rights
- Universal Declaration of Human Rights

BUT recognition within Canada is partial

- Provincial Human Rights Codes prohibit discrimination in housing
- Provincial laws set out tenants' rights
- Not in Charter of Rights and Freedoms

The right to housing does not mean that individuals can claim an immediate right to a house but ...

Housing strategies must ensure that "the measures being taken are sufficient to realize the right for every individual in the shortest possible time in accordance with the maximum of available resources." (CESCR, General Comment 4)



Canadian Charter of Rights and Freedoms

Section 7 :

Everyone has the right to life, liberty and security of the person and the right not to be deprived thereof except in accordance with the principles of fundamental justice

Section 15:

Every individual is equal before and under the law and has the right to the equal protection and equal benefit of the law without discrimination and, in particular, without discrimination based on race, national or ethnic origin, colour, religion, sex, age or mental or physical disability.

No place for courts in affordable housing fight, Ontario's top court rules

TORONTO – An argument over whether people have a constitutional right to adequate housing that governments are violating is not up to judges to decide, Ontario's top court ruled Monday in a split decision.

In its ruling, the Court of Appeal sided with a lower court that tossed the case without even hearing arguments on its merits.



Chapter 1

Housing Rights Are Human Rights



Canadians deserve safe and affordable housing. That is why the federal government is taking these additional Steps to progressively implement the right of every Canadian to access adequate housing. Our plan is grounded in the principles of inclusion, accountability, participation and non-discrimination, and will contribute to United Nations Sustainable Development Goals and affirm the International Covenant on Economic,

"Housing rights are human rights..." - Justin Trudeau (Nov 22, 2017)

STRATEGY

Following a period of consultation with housing partners, the federal government will introduce a bill to enable new legislation that promotes a human rights-based approach to housing. The new legislation will require the federal government to maintain a National Housing Strategy that prioritizes the housing needs of the most vulnerable. It will also require regular reporting to Parliament on progress toward the Strategy's targets and outcomes. A detailed National Housing Strategy report will be tabled every three years, starting in early 2020. The legislative approach will ensure that the National Housing Strategy is here to stay and grow.

The Rights-Based Approach in the NHS

Legislation enshrines the Right to Housing & creates mechanisms to enforce it

Government must ensure policies and programs are consistent with the R2H

Office of the Housing Advocate

Independent & wellresourced to support communities to bring claims forward Hearing mechanism
Includes members of affected communities
Issues findings and recommendations to government

National Housing Council

Shapes & monitors the NHS, includes representative from affected communities

Community-Based Initiatives
Lived-experience-led local monitoring of NHS
programs. Bring information to the Federal
Advocate about systemic barriers.
