Reaching Home R&R Basics

WHAT: Fund projects that address local needs and specific homelessness priorities.

Adopt wholesome approach + longer-term solutions

- WHO: Eligible recipients located in communities not eligible for funding through Designated Communities stream are eligible for Rural and Remote
- WHERE: Rural and remote communities in Ontario

WHEN: 2-year funding agreements (2020-2022)


Projects to start April 1, 2020 and end March 31, 2022

HOW: Evidence based, impact oriented, results driven





Funds Invested vs. Requested

Homelessness Partnering Strategy 2014-2019 (Past 5 Years)

- Supported 86 projects in Ontario
- Over 6.4 million dollars invested in rural communities across Ontario
- Over 19 million dollars requested
 - 2015 → \$4,427,422 requested
 - 2016-2019 → \$9,448,364 requested
 - 2017-2018 → \$1,618,594 requested
 - 2018-2019 → \$3,907,009 requested



Examples of Services/Programs

Homelessness Partnering Strategy 2014-2019 + Reaching Home

- Utility, heat and water assistance
- Rental arrear assistance
- Skill-building workshops
- Mobile Outreach Vehicles to enhance housing assistance services
- Basic needs
- Hiring Case Workers/Outreach Workers
- Purchase of building to convert to shelter
- Purchase of a vehicle to transport clients to and from appointments

- Financial literacy + budgeting seminars
- Housing Loss Prevention programs
- Housing First initiatives
- Youth transitional housing services
- Temporary shelter in motels due to lack of local shelter
- Intensive Case Management supports
- Youth transitional housing services













Red Lake Area Emergency Shelter *Realities of Rural Communities in ON*

- Youth ages 16 and 17 who no longer reside with parent(s)/guardian(s)
- Financial Trustee to be eligible for Ontario Works
- Meet youth where they are at due to lack of public transportation
- Human trafficking + homelessness
- Provides youth with:
 - Links to housing supports
 - Advocacy with schools and landlords
 - Employment readiness and life skills development





Regional Advisory Board (RAB)

Our Regional Advisory Board (RAB) volunteers assess applications based on the following criteria:

- ✓ The project meets the Reaching Home funding guidelines
- ✓ Helps to end homelessness and reduce the effects of poverty
- ✓ Demonstrates community partnerships, collaborations and system linkages
- ✓ Project meets a service gap or need
- ✓ Demonstrates agency sustainability and stewardship
- ✓ Demonstrates achievable objectives, activities and reporting requirements
- ✓ Geographically spread across Ontario
- ✓ Value for money is realized



Rural and Remote Trends Across Ontario...

- Lack of affordable housing across the province;
- Prevention and diversion programs are essential to ending homelessness and in turn, decreasing prevalence of migration to urban areas in Ontario;
- Capital dollars are vital in rural communities;
- Complex and entrenched poverty-related issues;
- Hidden homelessness is a huge challenge;
- Challenges hiring + keeping qualified staff;
- Lack of transportation; and
- High utility bills + delivery charges.





Timeline & Next Steps





Next Steps:

- Nine (9) rural communities in Ontario shortlisted for new Designated Communities
- A total of \$3,193,580 will be allocated (pending on funding available) in rural communities across Ontario for a two (2) year funding period of April 1, 2020 to March 31, 2022 (\$1,596,790 each year)
- Applications completed online on our <u>'Reaching Home Portal'</u>
- Applications close on January 20, 2020
- Applicants notified of funding decisions in March 2020
- Projects to start April 1, 2020
